## Champaben Vallabhbhai Mayani Best Woman Scientist Award

### Rules

1. **Name of award:** Champaben Vallabhbhai Mayani Best Woman Scientist Award.
2. **Sponsor of the award:** Society of Extension Education, Gujarat.
3. **Objectives of the award:** To provide recognition to outstanding woman extension personnel and to promote quality teaching/research/extension in the discipline of Home Science/ Extension Education/Agril. Extension/Vet. Extension/Dairy Extension.
4. **Nature of the award:** This award is meant for individual extension personnel. An award will consist of certificate and plaque. One award has been provided in the discipline of Home Science/ Extension Education/Agril. Extension/Vet. Extension/Dairy Extension.
5. **Frequency:** Every year
6. **Eligibility criteria:** This award is strictly meant for the **life members (minimum five years)** of the SEEG. All the extension personnel who have an independent teaching/research/extension experience for **a minimum of ten years** as assistant professor and its above in the discipline of Home Science/ Extension Education/Agril. Extension/Vet. Extension/Dairy Extension and their **age are above 35 years and maximum age limit is 62 years**.
7. **Administration of the award:** The award will be administered by SEEG. There will be judging committee consists of 7(Seven) well experienced extension educationist/professors/Scientists of the subject. The judging committee will be decided by the executive council under the leadership of President and Vice president of the society. The judging committee will evaluate the nominations as per award guide line and identify the outstanding scientist and make recommendation to SEEG. There should be minimum four members remain present from judging committee while recommending the nomination for award. Minimum three applications/entries should be received in this category for the evaluation process otherwise award will not be given. If no outstanding entries have been identified no award will be given in the subject.
8. **Evaluation criteria:** The focus will be on efforts made by extension personnel to serve the woman community in the interest of the country's agricultural development.
9. **Procedure:** Applications for the award will be invited by the SEEG before actual date of society annual meet cum gathering every year. Application in prescribed form will be available from SEEG website and accepted up to the prescribed date by SEEG every year. The judging committee will evaluate the nominations and identify outstanding entries and make recommendation to society. If no outstanding entries have been identified, no award will be given in the subject.
10. **Presentation:** The presentation of the award will be made on the annual meet cum gathering of the society every year.

10. Assistant professor & its equivalent and above are eligible for this award.
11. All the applicants are abiding by the decision of the concern judging committee.
12. **In all matters relating to the award, the decision of the judging committee shall be final and no correspondence on this account will be entertained**
